

**PRIVACY NOTICE ON THE PROCESSING OF PERSONAL DATA FOR KEEPING INTERNET ACCESS
RECORDS AS PER THE LAW NO. 5651**

As the data controller, Turcas Petrol Anonim Sirketi (“**Turcas**” or “**Company**”) may process your personal data for the purposes specified below in accordance with the Law on the Protection of Personal Data No. 6698 (“**Law**”).

a) Purposes for Processing Personal Data

Your personal data may be processed in accordance with the conditions of processing personal data that are specified in Articles 5 and 6 of the Law, for the purpose of ensuring legal, technical and commercial business security of the Company and related persons doing business with the Company.

b) Recipient Parties and Purposes for Transferring Personal Data

In order to achieve the aforementioned purpose , your personal data may be transferred to our subsidiaries, suppliers, competent public authorities and private persons or organizations, in accordance with the conditions and purposes of transferring personal data that are described in Articles 8 and 9 of the Law.

c) Methods and Legal Grounds for Personal Data Processing

The Company collects your personal data in the electronic environment for the purpose of providing internet access to you, p based on the legal ground set forth under Article 5 of the Law as “data processing is necessary for compliance with a legal obligation to which the data controller is subject” Your personal data may be processed and transferred for the purposes specified in sections (a) and (b) of this Privacy Notice.

ç) Data Subject’s Rights Specified In Article 11 of the Law

Please note that, as a data subject, you have the following rights pursuant to Article 11 of the Law:

- To learn whether your personal data are being processed,
- To request information if your personal data have been processed,
- To learn the purpose of the processing of your personal data and whether they have been used accordingly,
- To learn which third parties domestic or abroad your personal data has been transferred to,
- To request rectification in case your personal data has been processed incompletely or inaccurately and to demand the operations in this regard be reported to third parties your personal data has been transferred to,
- To demand the erasure or destruction of your personal data in the event that the reasons for the processing no longer exist even though it was processed in accordance with the Law and

other relevant provisions and to demand the operations in this regard be reported to third parties your personal data has been transferred to,

- To object to negative consequences to you that are concluded, as a result of analysis of the processed personal data through solely automatic systems,
- To demand compensation for the damages that you have suffered as a result of an unlawful processing of your personal data.

You may submit your applications concerning your above-listed rights by using [Turcas Petrol Anonim Sirketi Data Subject Application Form](#) that is accessible at the Company's Website. Depending on the nature of your request, your application will be concluded as soon as possible, and within 30 days at the latest, and in principle, free of charge. However, if the process requires additional costs, a fee may be demanded according to the tariff determined by the Personal Data Protection Board.
